## **Guaranteed Contract - Terms on Conditions**

1. Seller will provide, to buyer, registration papers on their new puppy if applicable.

2. The Seller will have the puppy current on vaccinations and wormings and will provide proof of dates on all vaccinations and wormings.

3. The buyer needs to have said puppy examined by a vet of their choice within 48 hours of purchase to engage the 1 year health guarantee. If the exam indicates at the time of sale, the puppy was unfit for purchase due to extreme illness, disease, or congenital disorder, the Buyer may return the puppy for the exchange of another puppy. However, it may have to be from a future litter. We do not refund any monies for any reason. Shipped puppies are not covered in the 48hr guarantee as I can't control once they leave my possession. Viral and Bacterial illness is also not covered as this could be picked up from any airport or a stop along your way home.

4. The Seller guarantees this puppy from fatal viruses for 48 hours from date of purchase. This includes; Distemper, Parvo, and Corona Virus. It DOES NOT include, Giardia, Coccidia, any type of worms, Kennel Cough, Hernias, Bacterial or Viral Infections, Mange, or any other minor common puppy illness. Coccidea and Giardia are very common in new puppies from stress. Its easily treated. Cherry eye and Entropia and umbilical hernias are not covered in this guarantee.

5. The Seller guarantees the puppy from 1 year of birth against fatal and life altering congenital and genetic defects which adversely affects the health of the puppy. This includes: Severe Hip Dysplasia (Which severly hampers a dog's movement and natural gait and is not from overweight or injury), Kidney, Heart, and Liver problems of a severe or life threatening or altering nature. Digestive issues are not covered as those can be treated with meds or food changes. This DOES NOT include any type of skin allergy or food allergy. Entropia and Cherry Eye are not life threatening and therefore not covered. If the dog dies within the guarantee time frame, we do require an autopsy to ascertain the cause of death. The Seller will replace the puppy with a puppy from another litter when one becomes available, in the event it was a genetic or hereditary defect. No refunds are given. If needed to return a puppy, shipping and all vet costs are buyer's responsibility. Replacement puppies are also shipped at buyers expense.

## Note:

Due to the nature of the Doodles and their large size, we cannot 100% guarantee a puppy against hip dysplasia. Should buyer's puppy have mild or moderate hip dysplasia, the puppy will NOT be replaced or purchase price refunded. Should buyer's puppy have severe dysplasia that requires euthanasia, a puppy replacement from next available litter will be provided and chosen by breeder. Before puppy is replaced, the following is required to be provided: a letter from a OFA licensed veterinarian providing x-rays with clear evidence of such claim, report from OFA proving severe dysplasia, a copy of report of euthanasia and registration papers will be rendered back to the breeder. For Mild or Moderate Dysplasia Nu Joint supplements are recommended. We also recommend feeding Pro Plan, Science Diet, Eukanuba, or Royal Canin ONLY. Many foods are causing DCM in dogs. If you chose not to feed these foods. The guarantee is void.

6. Seller must be notified within 2 business days of any findings of any problems. We do require two statements from two different licensed vets if any issues arise. We may also ask that our vet exam the puppy/dog. All vet bills incurred are buyer's responsibility.

7. If for any reason the said puppy is overweight or underweight or left to unkind conditions this guarantee is voided. Also, if you sell or give away this puppy the health guarantee is voided. It is not transferable.

8. In the event of any litigation in connection with this guarantee, the buyer agrees for the dispute to be held in Gallatin County, Illinois.

9. If you can no longer keep the said puppy, we reserve the right of 1st refusal. If we choose not to take the puppy back, we will however help you find a home for her. Our puppies are to NEVER end up in a shelter or humane society of any sorts for ANY reason!

10. We do require ALL our puppies to be spayed/neutered by 6 months of age. We do give breeding rights to approved homes only. Failure to have your puppy spayed/neutered by 6 months of age will result in voiding this health guarantee.

We can only estimate and guess adult size a color.
